1 Background

1.1 An email was sent to the Events Working Group to attend a meeting to be held on 16th September. Two council members were in attendance.

2 Recommendations for consideration

- 2.1 Approval is sought for the go ahead of the Lantern Parade led by Creative Youth Opportunities quoted at £500 for the following:
 Planning and Preparation
 Staff coordination and a Risk Assessment to escort children and their parents/guardians from the Welfare Centre to the Memorial Park for the annual Christmas Tree Lighting event to be held on the agreed day of 3rd December. To make this an annual event
- 2.2 The working group discussed an alternative use for this £500 budget which is to have Santa to hand out a small bag of sweets or a small gift to all children entering or leaving the Memorial Park. The person in question has been approached and they have agreed and are DBS checked. This would involve volunteers wearing a hi-vis vest, to keep the entrance to the Memorial Park clear and to use barriers that are already in place for crowd control to clearly define the queue and to direct the flow to prevent overcrowding and to ensure a safe navigation to the exit. To have signage if required.
- 2.3 Cost of sweets and bags total approximately £50 Cost of small gift total approximately £150
- 2.4 £500 budget has already allocated within the events budget for the Lantern Parade

3 Alternative Proposal from Creative Youth Opportunities

- 3.1 Creative Youth Opportunities to purchase some simple resources to create 50 Lanterns with the hope that these can be displayed in the Memorial Park and be removed after the service. Creative Youth Opportunities would like to be part of this Christmas Tree Lighting event Cost £77.12
- 3.2 Creative Youth Opportunities have asked for permission to display two large Poppies one Red and one Purple which have been created by CYO children to be attached to the Memorial Park railings
